Covid-19: Returning to Work

OSHA has developed some guiding principles to help everyone get back to work safe. Those principles include:

- 1. Hazzard Assessment
- 2. Hygiene
- 3. Social Distancing
- 4. Isolation of Sick Employees
- 5. Workplace Flexibility
- 6. Training of Employees
- 7. Anti-Retaliation of Employees

Guidance on Returning to Work

Masks, Am I Getting Enough Oxygen?

"Medical masks, including surgical masks, are routinely worn by healthcare workers throughout the day as part of their personal protective equipment (PPE) ensembles and do not compromise their oxygen

levels or cause carbon dioxide buildup. They are designed to be breathed



through and can protect against respiratory droplets, which are typically much larger than tiny carbon dioxide particles.

Consequently, most carbon dioxide particles will either go through the mask or escape along the mask's loose-fitting perimeter. Some carbon dioxide might collect between the mask and the wearer's face, but not at unsafe levels."

Heat Stroke vs. Exhaustion

It is important to know the difference between **Heat Stroke** and **Heat Exhaustion**.

<u>Heat Stroke</u> is a medical emergency that should be dealt with immediately.

Signs: Headaches, confusion, loss of consciousness, no sweat, hot red skin, nausea or vomiting, rapid heart rate.

What to Do: If someone is experiencing heat stroke, call 911 right away, DO NOT GIVE FLUIDS, and bring them to a cooler place.

<u>Heat Exhaustion</u> is not a medical emergency, should be handled the same way.

Signs: Dizzy or fainting, heavy sweating, cold palms, weak pulse, and excessive thirst.

What to Do: Remove the person and get to a cool, dry place, give them fluids, and have them lie down. The quicker you cat the better the results.


